Eagle Granite certifies that this mausoleum was inspected in our plant prior to shipping and is free from defects such as chipping, cracking and staining. Differences in the color of any particular granite shall not be treated as a breach of our guarantee or other statutory obligations. Proof of purchase will be needed to claim under this guarantee.

Our guarantee covers the granite portion of your mausoleum both manufactured and imported by Eagle Granite on the following terms purchased by you against material defects. At our discretion, we will repair or replace in part or whole, any mausoleum which is covered by our guarantee if the claim under our guarantee is justified in our reasonable opinion. If a replacement is offered by us, but identical materials are no longer available, we reserve the right to replace the granite with the nearest equivalent. This guarantee is strictly subject to you notifying us before having any work undertaken to rectify the problem.

Eagle's guarantee does not cover defects or damage arsing in respect of: the repair or replacement of any third party components; modification or misuse; physical, chemical or mechanical abuse; unauthorized repair; natural color differences, veining, pot marks and fissures; use other than for regular memorial purposes or a purpose which is not disclosed at the time of installation; moving parts or parts which are likely to perish over time (such as caulking, concrete, dowels and any metal pieces); improper installation, or acts of Nature, acts of violence, vandalism, flood or any other natural disaster.

In the unlikely event that you do need to claim under this guarantee, you must first contact the company/sales person/counselor that originally sold the mausoleum. If we deem the fault to be covered under Eagle's guarantee, we will contact you to begin assessing the claim.
